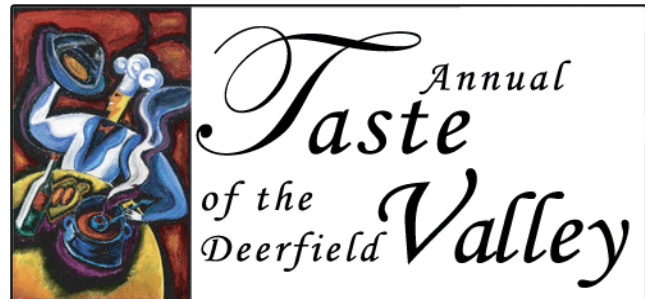




CELEBRATE THE VALLEY PARTICIPATION AGREEMENT For Restaurant Vendors

Restaurants who sign up by August 10th will receive:

- Your \$100 registration Fee and up to \$250 (cash) food reimbursement cost will be refunded to you within 30 days after the event by Celebrate The Valley Inc. base upon the menu in which you serve at the event. (All no shows and any restaurant that run out of food 2 hours before the event ends will forfeit all food reimbursement cost and your registration fee).

All restaurants will receive:

- Space at the event – approx 10x10.
- 2 Tables w/white linens + power.
- Access to water.
- A sign with your business name (you're welcome to bring your own).

You will be responsible for bringing anything else you will need to cook and serve your samples and decorate your booth/table. You should be prepared to server to between 800 and 1000 people.

Set Up

Set-up can begin as early as 8:00 AM and must be finished by 10:00 AM. All vehicles must exit the event area by 10:00 AM - Doors open at 11AM.

**Arrangements can be made in advance for partial set-up on Friday if needed.*
